WASHINGTON, SECOND FLOOR MEETING ROOM, KAUFMAN, TEXAS TO CONSIDER THE PROPOSED KAUFMAN COUNTY BUDGET FOR THE FISCAL YEAR OF OCTOBER 1, 2017 THRU SEPTEMBER 30, 2018, WHICH INCLUDES A 4% PER YEAR INCREASE FOR MOST COUNTY EMPLOYEES AND THE FOLLOWING SALARY INCREASES FOR ELECTED OFFICIALS AS FOLLOWS:

THIS BUDGET WILL RAISE MORE TOTAL PROPERTY TAXES THAN LAST YEAR'S BUDGET BY \$ 5,312,317 (12.87 %) AND OF THAT AMOUNT \$ 1,858,557.81 IS TAX REVENUE TO BE RAISED FROM NEW PROPERTY ADDED TO THE TAX ROLL THIS YEAR.
